ORDINANCE NO. 4-2011-06-20

ORDINANCE ADDRESSING FLOODPLAIN MANAGEMENT
PROVISIONS OF THE STATE CONSTRUCTION CODE

An Ordinance known as the Frankenmuth Township Floodplain Management Ordinance.

An Ordinance to designate an enforcing agency to discharge the responsibility of the Township of Frankenmuth located in Saginaw County, and to designate regulated flood hazard areas under the provisions of the State Construction Code Act, Act No. 230 of the Public Acts of 1972, as amended.

THE TOWNSHIP OF FRANKENMUTH ORDAINS:

Section 1. AGENCY DESIGNATED. Pursuant to the provisions of the State Construction Code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, as well as the *Interlocal Agreement dated April 14, 2004* (attached hereto) of the City of Frankenmuth, Township of Frankenmuth and Township of Blumfield establishing the *Construction Code Group*, the ***Construction Code Group*** is hereby designated as the enforcing agency to discharge the responsibility of the Township of Frankenmuth under Act 230, of the Public Acts of 1972, as amended, State of Michigan. Pursuant to the Interlocal Agreement Establishing the Construction Code Group, the Construction Code Group, on behalf of the Township of Frankenmuth, assumes responsibility for the administration and enforcement of said Act throughout the corporate limits of the community adopting this ordinance.

Section 2. CODE APPENDIX ENFORCED. Pursuant to the provisions of the State Construction Code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, Appendix G of the Michigan Building Code shall be enforced by the enforcing agency within the Township of Frankenmuth.

Section 3. DESIGNATION OF REGULATED FLOOD PRONE HAZARD AREAS. The Federal Emergency Management Agency (FEMA) Flood Insurance Study (FIS) Entitled **Saginaw County, Michigan (All Jurisdictions) 26145CV000** and dated **October 16, 1997** and the Flood Insurance Rate Map(s) (FIRMS) panel numbers of **26145C0200D; 26145C0205D; 26145C0210D and 26145C0255D**, dated **October 16, 1997**, are adopted by reference for the purposes of administration of the Michigan Construction Code, and declared to be a part of Section 1612.3 of the Michigan Building Code, and to provide the

content of the "Flood Hazards" section of Table R301.2(1) of the Michigan Residential Code.

Section 4. REPEAL. All ordinances or parts of ordinances of the Township which are in conflict with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

Section 5. SEVERABILITY. The provisions of this Ordinance are hereby declared to be severable and if any part is declared invalid for any reason by a court of competent jurisdiction it shall not affect the remainder of the Ordinance which shall continue in full force and effect.

Section 6. INSPECTION OF ORDINANCE. A copy of this Ordinance may be obtained from the Frankenmuth Township Clerk, at the following address: 240 West Genesee Street, Frankenmuth, Michigan, 48734.

Section 7. EFFECTIVE DATE. This Ordinance shall take effect 30 days after publication as required by law following adoption by the Township Board.

This Ordinance is hereby declared to have been adopted by the Frankenmuth Township Board, County of Saginaw, State of Michigan, at a regular meeting held on the twentieth day of June, 2011, and ordered to be given publication in the manner prescribed by law.
