Meeting Minutes

Present: Supervisor Hildner, Trustee Bierlein, Trustee Frahm, Treasurer Marshall
 Absent: Clerk Valone

Also present: Police Chief Mawer

Supervisor Hildner called the meeting to order at 7:00 P.M.

No public comment.

Minutes for the January 2018 meeting were reviewed. Motion by Bierlein to approve minutes, support by Frahm. Unanimously passed.

Chief Don Mawer gave his report. There were 271 calls for service and 12 traffic stops for January. Chief Mawer also handed out his 4th quarter report for 2017. Chief Mawer left the meeting.

There was no Zoning Administrator report. ZA Friend distributed the annual Special Use Permit Report prior to the meeting.

One building permit was issued in January:

The Planning Commission meeting was held on February 6. Grandpa Tinyø Farm gave an annual report and requested several changes to the permit to allow for larger size weddings. The PC approved an increase to 200 people, 50 cars for one year to be reviewed in 2019. Kim Zehnder abandoned her day care special use permit after moving to new building in the City. Andy Agans presented draft request for roadside stand at tree farm. Draft wind energy ordinance was forward to the city attorney for review. MSU Extension is giving information meeting on solar energy on March 14.

The Planning Commission also met with the City Planning Commission on February 12 to discuss the Industrial Park annexation for Frankenmuth Brewery.

Trustee Bierlein reported Parks and Recreation meeting. New officers were elected. Jaycees hope to have splash pad in construction by May. Change in off season rental rates for the pavilion.

The City of Frankenmuth EDC property of 9.08 acres was recommended for annexation to the City of Frankenmuth at a joint meeting of the City and Township Planning Commissions. Move by Bierlein, support by Frahm to allow annexation of the EDC property described. Unanimously passed. (Resolution 2018-5)

Resolution 2018-6 was offered by Frahm, support by Bierlein approving the Frankenmuth Business Park Planned Unit Development District. Unanimously passed.

Resolution 2018-7 for adoption of guidelines for poverty exemptions at 2018 rate was offered by Marshall, support by Bierlein. Roll call vote: Hildner Y Marshall Y Valone absent Bierlein Y Frahm Y. Unanimously approved.

Resolution 2018-8 to allow local residents to protest in writing to the Board of Review was offered by Marshall, support by Bierlein. Unanimously approved.

Treasurer Marshall presented budget amendments mostly regarding an increase in salary for the Deputy Clerk due to training expense. Move by Frahm, support by Bierlein to approve the recommended budget amendments. Unanimously approved.

Resolution 2018-9 Appointment of Construction Board of Appeals was made by Frahm, support by Marshall. Unanimously approved.

Resolution 2018-10 Adopting Construction Board of Appeals Procedures was made by Bierlein, support by Frahm. Unanimously passed.

Move to adjourn by Marshall, support by Bierlein. The meeting was adjourned at 7:34 p.m.
