Meeting Minutes

Present: Supervisor Hildner, Trustee Bierlein, Trustee Frahm, Treasurer Marshall, Clerk Valone

Supervisor Hildner called the meeting to order at 7:27 P.M.

No public comment.

Minutes for the February 2018 meeting were reviewed. Motion by Bierlein to approve minutes, support by Frahm. Unanimously passed.

Chief Don Mawer gave his report. There were 286 calls for service and 42 traffic stops for February. Chief Mawer left the meeting at 7:33 P.M.

Zoning Administrator Friend reviewed activity for the past year. Of note, there were 5 new home builds (most of which will be annexed to the City). There will also be a rewrite of the zoning ordinance for solar and wind ordinances, and some smaller items.

The Planning Commission meeting was held on March 6. John Friend already covered most of it. Dean Haubenstricker went to an Extension program; the afternoon had good P.A. 116 and assessing information.

Trustee Bierlein reported for the Parks and Recreation committee. The Splash Pad funding is almost ready. Women's Club is worried about parking for concerts this summer because school district is repaving lots. Levee 1.25 inches shorter than regulation. City still working on plan.

Treasurer Marshall and Clerk Valone met with the Deuring earlier this month and had a good meeting regarding the cemetery ordinance. Election training is starting; letters will

go to election workers soon to see if they are still interested in working August and November. They will have training through the County when the new tabulators arrive.
